## Sailing Instructions

### 1 ORGANIZING AUTHORITY

- 1.1 Chicago Corinthian Yacht Club is the Organizing Authority for this event.

### 2 RULES

- 2.1 The series will be governed by the rules as defined in *The Racing Rules of Sailing*.  
2.2 The following US Sailing prescriptions will not apply: 60, 63.2, and 63.4.  
2.3 Appendix V1 and T is in effect.  
2.4 The Club 420 fleet shall sail with jib and main only. This changes Club 420 class rules 1.2.  
2.5 In the event of a conflict, these sailing instructions shall supersede all previously posted notices.

### 3 NOTICES TO COMPETITORS

- Notices to competitors will be posted on the official notice board on [racing.corinthian.org](http://racing.corinthian.org).

### 4 CHANGES TO SAILING INSTRUCTIONS

- Any change to the sailing instructions will be posted on the official notice board or announced by loudhailer on the water prior to the warning signal of each race.

### 5 ELIGIBILITY AND ENTRY

- 5.1 The series is open to all boats of the Laser, Vanguard 15, Rhodes 19 and 420 sailboats.  
5.2 An eligible boat may enter by submitting the online entry form together with the appropriate fee at [racing.corinthian.org](http://racing.corinthian.org).

### 6 SIGNALS MADE ASHORE

- 6.1 Signals made ashore will be displayed from the CCYC flagstaff.  
6.2 When flag AP is displayed ashore, '1 minute' is replaced with 'not less than 30 minutes'. This changes race signal AP.

### 7 RENTED BOATS

- 7.1 Seasonal 420 Charters are provided by Corinthian University. Prior to registration all participants must apply for a seasonal charter by contacting [juniorsailing@corinthian.org](mailto:juniorsailing@corinthian.org).  
7.2 Seasonal charter participants shall check in at least 75 minutes prior to their scheduled warning to secure their assignment.  
7.3 A 420 competitor who has entered a seasonal charter agreement shall notify [juniorsailing@corinthian.org](mailto:juniorsailing@corinthian.org) in writing no less than 48 hours prior to the check-in time for a scheduled session if he or she will not use a rented boat for that session.

8 **SCHEDULE**

8.1 All competitors shall register on [racing.corinthian.org](http://racing.corinthian.org) prior to the day's racing events.

8.2 Racing will be held as shown in the following table:

8.3 The scheduled time of the first warning signal for all classes is 1000 each race day and there will be no warning signal after 1200.

9 **SAILING INSTRUCTIONS**

The sailing instructions will be available no later than the Wednesday prior to the first race day of the series. They will be posted on the official notice board and on the CCYC website at [racing.corinthian.org](http://racing.corinthian.org).

10 **RACING AREA**

10.1 The racing area for all fleets will be in the open waters of Lake Michigan east, northeast or southeast of the entrance of Montrose Harbor or, at the discretion of the race committee, in the waters of Montrose Harbor.

11 **PENALTY SYSTEM**

11.1 Rule 44.1 is changed so that the Two-Turns Penalty is replaced by the One-Turn Penalty.

12 **PROTESTS AND REQUESTS FOR REDRESS**

12.1 Routine movement of autonomous marks will not be grounds for redress. This includes minor readjustments, marks returning to station after having been pushed away by a competitor, and collisions with marks that are not actively marks of the course presuming these collisions do not cause damage. This changes RRS 60.1(b).

13 **COACHING**

13.1 The organizing authority may provide on the water coaching during the racing.

13.2 Only for the purposes of instruction 14.1, rule 41 will not apply.

14 **SCORING**

14.1 Nine completed races constitute a series.

14.2 Once a series has been completed, each boat may exclude her worst scores, one race for every 5 sailed, rounding up, for the entire series.

15 **BERTHING**

15.1 Competitors for this event are encouraged to contact Westrec Marina (Montrose Harbor) for berthing instructions:

**16 SAFETY REGULATIONS**

- 16.1 U.S. Coast Guard approved PFDs shall be worn properly secured from the time a boat leaves the dock until she returns to the dock. This changes the Part 4 preamble and rule 40.
- 16.2 Unless equipped with an engine, all boats shall have an attached bow line conforming to its class rules. If a class does not have such a rule, the line must be at least 15 feet in length, 1/4 inch in diameter, and properly attached at all times.
- 16.3 Boats equipped with daggerboards shall tether them to the boat.
- 16.4 Competitors shall not leave Montrose Harbor until the signal boat is on the water.
- 16.5 When races are sailed in Montrose Harbor a boat shall not leave Montrose Harbor unless there is no more racing for the day or the boat has withdrawn from racing for the day.
- 16.6 A boat that withdraws from a race shall promptly notify the race committee.
- 16.7 Due to the COVID-19 pandemic, all participants shall comply with State, Local and Club rules and guidelines.

**17 CLEANLINESS**

- 17.1 CCYC is an all-volunteer club, as such all participants and guests are required to clean up any spaces occupied on club grounds and leave them as they found them.

**14 PRIZES**

Series prizes will be awarded for the top finishers in the Laser, Vanguard 15, Rhodes 19 and 420 fleets, number of prizes will depend on number of participants in each fleet.

**15 DISCLAIMER OF LIABILITY**

Competitors participate in the regatta entirely at their own risk. See rule 4, Decision to Race. The Organizing Authority will not accept any liability for material damage or personal injury or death sustained in conjunction with or prior to, during, or after the regatta.

**16 PHOTOGRAPHY AND VIDEO RIGHTS**

Competitors give absolute right and permission for any photographs or video footage taken of themselves or their competing boat to be published in any media whatsoever for editorial, commercial purposes, or to be used in press information.

## Addendum A

### *DF65 Fleet*

#### 1 **RULES**

The regatta will be governed by the rules as defined in *The Racing Rules of Sailing*: Appendix E and the DragonForce 65 Restricted Class Rules.

#### 2 **ELIGIBILITY AND ENTRY**

2.1 The series is open to DragonForce 65 remote controlled sailboats only.

a) The use of A-Plus rigs is prohibited.

2.2 An eligible boat may enter by submitting the online entry form together with the appropriate fee at:[link]

2.3 All boats must be properly registered online in order to compete.

2.4 Registered competitor shall be the skipper of his/her boat.

#### 3 **FEES**

The fee for the series is: \$30.00.

#### 4 **SCHEDULE**

4.1 Onsite check-in starts at 1300.

4.2 The schedule is the same as the NOR

#### 5 **CHANGES TO SAILING INSTRUCTIONS**

The Sailing Instructions will be available no later than the Wednesday before the first event and will be posted online.

#### 6 **RACING AREA**

The racing area will be Montrose Harbor near the foot of the CCYC Lawn.

#### 7 **SCORING**

7.1 Five (5) races will constitute a series.

- 7.2 Once a series has been completed, each boat may exclude her worst scores, one race for every 5 sailed, for the entire series. *This changes RRS A2.*
- 7.3 The value for a DNC (Did Not Compete) score shall be the number of boats checked-in plus two (2) for that day of racing. *This changes RRS A9.*

Series Awards: 1st, 2nd, and 3rd overall
